Item Description: Honoring June 2023 as LGBTQ+ Pride Month.

This item is submitted pursuant to the provision checked below:

Emergency Situation (54954.2(b)(1) - majority vote required)

Determination by a majority vote of the legislative body that an emergency situation exists, as defined in Section 54956.5.

Immediate Action Required (54954.2(b)(2) - two-thirds vote required)

Subject: Resolution to Honor June 2023 as LGBTQ+ Pride Month

RECOMMENDATION

Adopt a Resolution to honor June as LGBTQ+ Pride Month in the City of Berkeley and authorize the City Manager to fly the Rainbow Flag every year in the month of June.

BACKGROUND

The City of Berkeley has a long and notable history of leadership in promoting LGBTQ+ rights. As early as the 1970s, Berkeley became one of the first cities in the United States to adopt legislation prohibiting discrimination based on sexual orientation. This groundbreaking step paved the way for other cities and states to follow suit and marked Berkeley as a trailblazer in the fight for LGBTQ+ equality.

Berkeley honors special days and months such as National Freedom to Marry Day and LGBTQ+ Mental Health Awareness Month and also was the first city council in the nation to endorse marriage equality.

The City of Berkeley has continued each year to honor June as a symbolic month in which LGBTQ+ people and allies come together to celebrate and affirm freedom and pride.

RESOLUTION HONORING JUNE 2023 AS LGBTQ+ PRIDE MONTH

WHEREAS, the City of Berkeley recognizes the importance of a diverse and inclusive community that embraces individuals of all sexual orientations, gender identities, and gender expressions; and

WHEREAS, Berkeley seeks to highlight the importance of equality and freedom for the lesbian, gay, bisexual, transgender, and queer community, acknowledging their valuable contributions to our vibrant community; and

WHEREAS, Berkeley was the first city in the nation to establish a Domestic Partner registration system that includes same-gender couples, and the first to endorse marriage equality; and

WHEREAS, many of the people who live, work, attend school, and visit Berkeley and contribute to Berkeley's culture, values, and economy are part of the LGBTQ+ community; and

WHEREAS, despite significant advancements, discrimination, violence, and injustices against members of the LGBTQ+ community persist, both locally and globally, making it crucial for Berkeley to stand in solidarity with all members of the LGBTQ+ community; and

WHEREAS, June is internationally recognized as Pride Month, commemorating the historic Stonewall Riots of June 1969, which marked a turning point in the LGBTQ+ rights movement; and

WHEREAS, it is essential to acknowledge that the transgender community, in particular, has been at the forefront of the struggle for LGBTQ+ rights, facing disproportionate levels of discrimination, violence, and marginalization; and

WHEREAS, it is imperative that Berkeley denounce the alarming surge of more than 340 anti-LGBTQ+ bills brought forward by state legislatures around the country - more than 150 specifically targeting the transgender community - and growing political attacks that threaten their rights, dignity, and well-being; and

WHEREAS, the City of Berkeley affirms its unwavering support for the transgender community and condemns all forms of discrimination and prejudice against transgender, genderqueer, and gender nonconforming individuals; and

WHEREAS, the City of Berkeley recognizes the importance of centering the transgender community within the larger LGBTQ+ movement and elevating their voices to promote understanding, empathy, and societal change;
